Sub: **Implementation of reservation of 10% seats in Postgraduate (PG) Courses for the Economically Weaker Section (EWS) candidates by enhancing of PG seats in the existing Dental Colleges/ Institutes u/s 10A of the Dentists Act, 1948 for the academic session 2020-2021- Regarding.**

Sir/ Madam,

I am directed to refer the subject matter regarding Implementation of reservation of 10% seats in Postgraduate (PG) Courses for the Economically Weaker Section (EWS) candidates by enhancing of PG seats in the existing Government Dental Colleges/ Institutes under the control of State Governments.

In this connection, I am directed to clarify that the modality of increased uptake of 25% (to accommodate 10% EWS candidates) can be implemented over the period of two years i.e. 2019-20 & 2020-21 which can amount to 12.5% increase in the current year and 12.5% in the next year or may be in one go. Further, the 10% EWS quota can be implemented without affecting the current categories criteria. For example, if a college has 100 seats and 25% seats are increased, the total number of seats comes out to be 125. If 10% EWS quota is applied it accounts to 12.5 which can be considered as 13 seats. SC/ST/OBC Quota if applied would account to 62 seats. Adding the total reservation will result into 75 seats (EWS+SC/ST/OBC). Deducting this quota from the total number of seats 125 - 75 = 50. Hence, the unreserved seats remain the same and concluding that the current criteria would not be disturbed by implementing EWS quota. SC/ST category candidates cannot apply for EWS quota. However, OBC creamy layer candidates can avail the benefits of EWS quota.

In view of the above, you are requested to send your proposal under the EWS Scheme in consultation with DMEs u/s 10A of the Dentists Act, 1948 for the academic session 2020-2021 **not later than 7th of June, 2019**. The above proposal is applicable to the following Government Dental Colleges for increase of 10% EWS Quota:-

1. Government Dental Colleges those are likely to be granted letter of Permission in the academic year 2019-20 for admission of 1st batch of BDS students.
2. Government Dental Colleges which are in the state of renewal or permission for admission of fresh batch of BDS students and
3. Government Dental Colleges of which BDS Degree is recognized.

You are requested to ensure that the additional facility required i.e. teaching, training, beds and faculty, etc. for the increase as per minimum standard requirements for dental colleges for 40/50/60/100 admissions, as per DCI regulations, shall be put in place by the time the said increase intake capacity of the college comes up for recognition. You are further requested to furnish the program-wise seat increase matrix along with course-wise information as per the enclosed format.

This issues with the prior approval of the Executive Committee of the DCI.
