Sub: CURBING THE MENACE OF RAGGING IN EDUCATIONAL INSTITUTIONS – IMPLEMENTATION OF DIRECTIONS OF HON'BLE SUPREME COURT OF INDIA - DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009 – Regarding.

Sir/Madam,

In continuation to DCI's letter No.DE-167-2011/A-520 dated 15.04.2011 on the above mentioned subject, I am directed to say that as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, it is the responsibility of the institution to ensure that no incident of ragging takes place in their dental institution.

2. In view of the above, the relevant extract of Regulation No. 9.1.9 is reproduced below for your kind perusal and ready reference.

9 Measures for prevention of ragging at the institute level:-

9.1.9 To make the community at large and the students in particular aware of the dehumanizing effect of ragging, and the approach of the institution towards those indulging in ragging, big posters (preferably multicolored with different colours for the provisions of law, punishments, etc.) shall be prominently displayed on all Notice Boards of all departments, hostels and other buildings as well as at vulnerable places. Some of such posters shall be permanent nature in certain vulnerable places.

3. In this context, I am directed to request you that such posters referred above must contain DCI's contact information in bold and bright colours, meant for reporting of ragging cases by students, as under:-
