I am directed to invite your kind attention to DCI's aforesaid letters and to request that the feedback on the incident of ragging as and when take place in your institution and punishment awarded may kindly be sent immediately to Shri Devender Kumar, Under Secretary, Ministry of Human Resource Development, Department of Higher Education, Room No. 405 'C', Shastri Bhawan, New Delhi-110 001 within 7 days under intimation to DCI.

It may also kindly be intimated whether the following provision has been incorporated in the prospectus of your college for the session 2008-09:

> "If any incidents of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the institutions".

A copy of the prospectus incorporating the above provision may kindly be sent to the aforesaid officer Shri Devender Kumar, Under Secretary, Ministry of Human Resource Development, New Delhi, direct under intimation to DCI alongwith a copy of prospectus containing the information so as to enable DCI to apprise the Ministry of Human Resource Development accordingly as they have to incorporate the information in the reply to be submitted to the Hon'ble Supreme Court of India.

I am further directed to say that since the academic session 2008-09 is commencing shortly, you are requested to take all possible steps/measuregin your institution so as to ensure that no ragging of any type take place in your institution and in case concerned students indulge in ragging despite the instructions on ragging, strict action should be initiated against the concerned students as per the guidelines given by the Hon'ble Supreme Court of India in

its order 16.5.2007 referred to above and action taken in the matter may kindly be reported to Shri Devender Kumar, Under Secretary, Ministry of Human Resource Development, New Delhi, direct under intimation to DCI.
