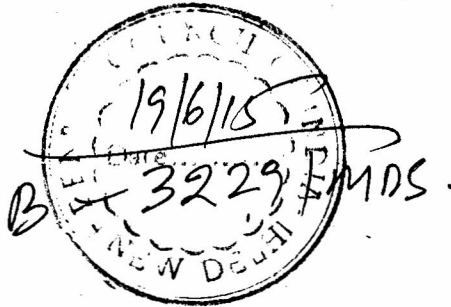

NOTIFICATION

S.O.....In exercise of the powers conferred by sub-section (2) of section 10 of the Dentists Act, 1948 (16 of 1948), the Central Government, after consultation with the Dental Council of India, hereby, makes the following amendments in Part-I of the Schedule to the said Act, namely:-

2. In the existing entries of column 2 & 3 against Serial No.38, in Part-I of the Schedule to the Dentists Act, 1948 (16 of 1948) pertaining to recognition of Dental Degrees awarded by Lalit Narayan Mithila University, Darbhanga, against Dr. S.M. Naqui Imam Dental College, Darbhanga, the following substitutions shall be made:
