**NOTIFICATION**

S.O..... In exercise of the powers conferred by sub-section (2) of section 10 of the Dentists Act, 1948 (16 of 1948), the Central Government, after consultation with the Dental Council of India, hereby, makes the following amendments in Part-I of the Schedule to the said Act, namely:-

2. In the existing entries of column 2 & 3 against Serial No.97, in Part-I of the Schedule to the Dentists Act, 1948 (16 of 1948) pertaining to recognition of dental degrees awarded by Kerala University of Health Sciences, Kerala, the following entries shall be inserted thereunder:-

IV. Govt. Dental College, Kottayam

**Master of Dental Surgery**

Oral & Maxillofacial Surgery

MDS (Oral Surg.), This shall be a recognized dental qualification when granted by Kerala University of Health Sciences, Kerala in respect of MDS students of Oral & Maxillofacial Surgery with 2 seats being trained at Govt. Dental College, Kottayam, if granted on or after 9.7.2013.

Prosthodontics and Crown & Bridge

MDS (Prosth.), This shall be a recognized dental qualification when granted by Kerala University of Health Sciences, Kerala in respect of MDS students of Prosthodontics and Crown & Bridge with 2 seats being trained at Govt. Dental College, Kottayam, if granted on or after 6.7.2013
