**NOTIFICATION**

S.O..... In exercise of the powers conferred by sub-section (2) of section 10 of the Dentists Act, 1948 (16 of 1948), the Central Government, after consultation with the Dental Council of India, hereby, makes the following amendments in Part-I of the Schedule to the said Act, namely:-

2. In the existing entries of column 2 & 3 against Serial No.53, in Part-I of the Schedule to the Dentists Act, 1948 (16 of 1948) pertaining to recognition of dental degrees awarded by **Baba Farid University of Health Sciences, Punjab**, the following entries shall be inserted thereunder:-

**Bachelor of Dental Surgery**

(This shall be a recognized dental qualification when granted by **Baba Farid University of Health Sciences, Punjab** in respect of BDS students of Shaheed Kartar Singh Sarabha Dental College & Hospital, Ludhiana (Punjab with **50 seats**, if granted to the first batch of BDS students admitted during the academic session **2009-10** only as a one time measure not be quoted as precedent)
