S.O..... In exercise of the powers conferred by sub-section (2) of section 10 of the Dentists Act, 1948 (16 of 1948), the Central Government, after consultation with the Dental Council of India, hereby, makes the following amendments in Part-I of the Schedule to the said Act, namely:-


2. In the existing entries of column 2 & 3 against XIV of Serial No.60, in respect of Y.M.T. Dental College & Hospital, Navi Mumbai, in Part-I of the Schedule to the Dentists Act, 1948 (16 of 1948) pertaining to recognition of dental degrees awarded by Maharashtra University of Health Sciences, Nashik, the following entries shall be inserted thereunder:-

(if granted on or after 13.07.2010)
- (ii) Conservative Dentistry & Endodontics
(if granted on or after 25.06.2010)
- (iii) Oral & Maxillofacial Surgery
(if granted on or after 29.06.2010)
- (iv) Periodontology
(if granted on or after 01.07.2010)
- (v) Orthodontics & Dentofacial Orthopedics
(if granted on or after 03.07.2010)

- MDS (Oral Path.), Maharashtra University of Health Sciences, Nashik
- MDS (Cons. Dent.), Maharashtra University of Health Sciences, Nashik
- MDS (Oral Surgery), Maharashtra University of Health Sciences, Nashik
- MDS (Perio.), Maharashtra University of Health Sciences, Nashik
- MDS (Ortho.), Maharashtra University of Health Sciences, Nashik


